NOTICE is hereby given that a general municipal election will be held on Tuesday, November 2, 2021 from 7:00 A.M. until 7:00 P.M. in the City of Miami, Florida, at the polling places in the several election precincts designated by the Miami-Dade County Supervisor of Elections, at which election the qualified electors participating therein will vote for the following municipal officers: Mayor who is to be elected citywide and two District Commissioners who are to be elected from single member Districts 3 and 5. A run-off election, if required, is to be held on Tuesday, November 16, 2021. Pursuant to Section 101.20, Florida Statutes, the Official Sample Ballot below lists all of the candidates for the offices of the Mayor and City Commissioner single-member Districts 3 and 5 for the November 2, 2021 General Municipal Election.

**Proposed Charter Amendment for the Lease and Development of Virginia Key Marina**

Shall Miami's Charter be amended authorizing City to waive competitive bidding, negotiate, execute 75 year waterfront lease (marinas, restaurants, marine related uses) of approximately 27 acres (generally 3301, 3307, 3605, 3501 Rickenbacker Causeway) with Biscayne Marine Partners LLC, for minimum:

- \$115,000,000 tenant capital investment
- \$2,750,000 annual rent (10% for Virginia Key Beach Park Trust) or fair market value
- 6% gross boat storage, fuel revenues; 4% gross revenues from other sources?

**Propuesta de enmienda a la Carta Constitucional para el arrendamiento y construcción de Virginia Key Marina**

¿Deberá enmendarse la Carta Constitucional de Miami de modo de autorizar a la Ciudad a eximir la licitación competitiva, negociar y ejecutar un contrato de arrendamiento de propiedades frente al mar por 75 años (marinas, restaurantes, usos marítimos afines) de alrededor de 27 acres (en términos generales 3301, 3307, 3605, 3501 Rickenbacker Causeway) con la compañía *Biscayne Marine Partners LLC*, para un mínimo de:

- \$115,000,000 de inversión de capital del arrendatario,
- \$2,750,000 de renta anual (10% para el Fideicomiso de Virginia Key Beach Park) o el valor justo de mercado, y
- 6% de almacenamiento bruto de embarcaciones, ingresos por combustible; 4% de ingreso brutos provenientes de otras fuentes?
