Notice is hereby given that a Special Election will be held on Tuesday, August 23, 2022 from 7:00 A.M. until 7:00 P.M. in the City of Miami, Florida, at the polling places in the several Special Election precincts designated by the Supervisor of Elections of Miami-Dade County, Florida, as set forth herein, unless otherwise provided by law, and submitting to the qualified electors of the City of Miami, Florida, the following question listed on the Official Sample Ballot below.

Qualified electors will have the option to vote **Yes** or **No** on the charter amendment question.

**Proposed Amendment to Riverside Wharf lease on City's waterfront property on the River**

Shall Miami's Charter be amended authorizing the City Commission, by 4/5ths vote, to amend the existing Riverside Wharf lease, thereby increasing base rent by 50 percent or fair market rent, if greater, increasing private investment in the property from \$7,000,000 to \$30,000,000, extending the term by 50 years, and requiring that tenant construct the project consistent with zoning, and resiliency requirements, and construct a new seawall and publicly accessible Riverwalk?

**Propuesta de enmienda al contrato de arrendamiento de Riverside Wharf de una propiedad de la Ciudad frente al Río**

¿Deberá enmendarse la Carta Constitucional de Miami de modo de autorizar a la Comisión de la Ciudad, mediante un voto de cuatro quintos (4/5), a enmendar el contrato de arrendamiento actual de Riverside Wharf, para así incrementar el alquiler básico un 50 por ciento o el alquiler del mercado justo, si fuera mayor, y aumentar la inversión privada en la propiedad de \$7,000,000 a \$30,000,000, extender el término 50 años, y exigir que el arrendatario construya el proyecto de forma consistente con los requisitos de zonificación y resiliencia, y construir un nuevo malecón y un paseo junto al río (Riverwalk) de acceso público?
