TENTH EXTENSION OF STATE OF LOCAL EMERGENCY

WHEREAS, Florida Governor Ron DeSantis in accordance with Article IV Section (1)(a) of the Florida Constitution and Chapter 252, Florida Statutes, promulgated Emergency Order 20-52 to declare a state of emergency in the State of Florida in response to Novel Coronavirus ("COVID-19"); and

WHEREAS, Florida Governor Ron DeSantis in accordance with Article IV Section (1)(a) of the Florida Constitution and Chapter 252, Florida Statutes, promulgated Emergency Order 20-114 extending Executive Order 20-52 for another sixty (60) days; and

WHEREAS, on March 12, 2020, City of Miami Mayor Francis X. Suarez declared a State of Local Emergency in response to COVID-19 in and for the City of Miami, Florida; and

WHEREAS, in accordance with Section 252.38(3)(a), Florida Statutes, the duration of each state of emergency declared locally is limited to 7 days and may be extended, as necessary, in 7-day increments; and

WHEREAS, on March 17, 2020, March 24, 2020, March 31, 2020, April 7, 2020, and April 14, 2020, April 21, 2020, April 28, 2020, May 5, 2020, and May 12, 2020, City of Miami Mayor Francis X. Suarez declared extensions to the State of Local Emergency in response to COVID-19 in and for the City of Miami, Florida; and

WHEREAS, despite previous emergency measures the effects of COVID-19 continue to require extraordinary and immediate actions by the City of Miami in order to protect the public health, safety, and welfare;

NOW THEREFORE, as **Mayor** of the City of Miami and pursuant to the authority vested in the Office of the Mayor by virtue of §4(g)(3), of the City Charter and Chapter 252 of the Florida Statutes, I hereby declare an extension to the State of Local Emergency. This Tenth Extension of State of Local Emergency includes all of the City of Miami.

Pursuant to this Declaration, the City Manager is hereby ordered to take whatever prudent actions are necessary to protect the health, safety, and welfare of the community.
